2.2 Presentation of May 16, 2023, CCAL Financial Report (F\&M Bank Statement and CCAL Activities (4/2/23-4/30/23) \$11,130.25; no debits or credits; new balance is $\$ 11,120.25$. Motion by Justin, second by David, all sites approved the minutes with the absence of Gregori.

3.2 2023/24-2024/25 CCAL President and Vice President (Action) Com. Felt discussed next year's presidency - David Sanchez will be CCAL President, Justin Woodbridge will take the Vice President position.
3.3 2023/24 Proposed Budget: (Action) Com. Felt reviewed the proposed budget for 2023-2023 school year; this was discussed at the previous meeting. Proposed 2023-2024 budget is $\$ 12,900$; including assessment fees $\$ 2200$ / site, commissioner's stipend $\$ 9,000$, commissioner's mileage $\$ 700$, webmaster stipend $\$ 1200$, website fee $\$ 1000$, athletic excellence award $\$ 250$, lifetime passes $\$ 100$, CCAL passes $\$ 50$, rental fees $\$ 400$, and miscellaneous $\$ 200$. Motion from David to approve budget, seconded from Justin; all sites approved; Gregori absent.
3.4 2023/24 Proposed CCAL Meeting Schedule: (Action) Com. Felt discussed the proposed leadership meeting schedule for 2023-2024. Motion to accept meeting schedule by Phuc; seconded by Justin. All sites approved the schedule. Gregori absent.

WAC - \$8/\$6; $\$ 7 \$ / 6$
TVL - $\$ 8 / \$ 5 ; \$ 7 / \$ 5$
SJAA - \$9/6; \$7/\$4
Most leagues allow a $\$ 1$ increase for rivalry games.
ADs are recommending we price our games at $\$ 10$ and $\$ 5$ across the board.
After discussion, the team decided to table ticket increase prices to the August 29th meeting after Modesto City Schools completes their Equity Study and Turlock Unified discusses with Cabinet.
