## CCAL Leadership Team Meeting March 11, 2021 Video Conference Meeting- 11:30pm

- 1.0 Welcome and Introductions: President Freeman called the meeting to order at 11:34. Angela welcomed Barney Gordon, Bryan Moore, Mark Chase, and Marie Russell to our meeting.
  - 1.1Period for Public Discussion: Members of the public may address the Leadership Team on items not on the agenda. - 2.0 Old Business: Commissioner Felt
  - 2.1 Presentation of February 17, 2021 CCAL Leadership Team Minutes Derek made a motion to approve the minutes; Amanda seconded the minutes. All six sites approved the minutes.
  - 2.2 Presentation of March 11, 2021 CCAL Financial Report (F&M Bank Statement and CCAL Activities (2/1/21-2/28/21) Ed stated that there has not been any activity since the last statement; ending balance was \$9205.75; Feb. 1<sup>st</sup> Feb 28<sup>th</sup> there were no transactions so the balance remains at \$9205.75. Jason made a motion to approve the financial report; Derek seconded the approval. All six sites approved the report.

3.0 New Business: Commissioner Felt

- 3.1 Officials Assignor Update: Mark Chase Guidelines for ADs have these been read and pushed out to coaches? Make sure that these guidelines are pushed out to coaches so they know what the expectations are.

  - 3.1.1 Football schedules are in for this league; Mark stated that they are staring to tell schools to possibly schedule games on Thursday or Saturdays. They are down officials for a number of reasons. They will do their best to put 5 referees at the games, however know that they are down referees. Ed asked when we would need to know if we need to move a football date to a Thursday or a Saturday; Bryan stated right now we are set for our season because the Fresno team is helping us out.
- 3.2 Season One Progress Report: Felt the Cross County meets and swim meets have went well; golf has also worked out well.
- 3.3 Season Two- Update/Sports to be Played/ Testing Procedures: Felt –

Prior to begin season two discussion Ed wanted Barney, Marie, and Brad to discussed what the two districts have been working on.

Brad – MCS started testing all football players; we had a couple of kids test positive; they are working through those implications. We need to be prepared to adjust game schedules in case we have to have teams not play. Football admissions – WAC has decided to not charge admissions for gate fees; what do we want to do for CCAL? MCS preference would be to be consistent with both leagues in their district. MCS determined that spectators would be allowed to attend to supervise students for immediate family. 2 household members per athlete; cheer would be able to perform sideline cheer and half-time cheer with 10' social distancing, must be wearing masks, must be tested just as football players are.

Barney – Stated that if we are going to charge entrance to football because of paying for officials then we don't need to charge; Dave Walls stated that the money is used for awards, Block Ps, etc. Dave Walls asked various leagues and some are charging and some are not.

Ed asked 2 tickets per athlete/cheer leader; Ed asked if we needed to clear out the stadium between games. Brad stated that he thinks based on stadium capacity we should be ok with not having to clear out the stadium.

Barney stated that TUSD is in agreement with MCS as they have been working together. Barney stated that we are working in TUSD with being able to stream the games.

The consensus is that we will not charge an entrance fee and 2 tickets per athlete will be given to immediate household spectators to support supervision of their student for both football and cheer. Also, only essential staff is allowed to be at the game to support supervision of students and parents.

Season Two – Ed stated that he felt that it is better to put all sports together into one seasons that are in the same colored tier. ADs and Ed are recommending to move volleyball to Season 3. MCS is trying to evaluate the feasibility to get all athletes for indoor sports to test and supported moving volleyball to Season 3. We are going to continue with football, girls' tennis, and boys' golf with moving volleyball (yellow tier sports) in Season 3.

- 3.4 Season Three Sports to be Played/ Weekly Schedule: Felt ADs met yesterday and moved some of the start times back to adjust for the use of facilities. Ed reviewed the proposed Season Three contest dates and asked for a recommended the changed Season 3 start times for baseball, softball, soccer, water polo, volleyball, and wrestling.
