2.0 Old Business: Commissioner Felt

- 2.1 Presentation of May12, 2021 CCAL Leadership Team Minutes Ed reviewed the minutes; motion made by Jason Manning; second from Amanda. All sites approved the minutes.
- 2.2 Presentation of August 18, 2021 CCAL Financial Report (F&M Bank Statement and CCAL Activities (5/1/21-7/31/21). Ed reviewed our league's finances and reported expenses and credits since the last meeting. The current balance of our account is \$5089.69. Motion made to accept the financial report made by Derek Pendley and second from David Sanchez; all six sites approved the report.

 - 3.1 MCS & TUSD Sports Protocols: MCS & TUSD Representatives
 - 3.2 Officials Assignor Update: Mark Chase check volleyball schedule times to ensure we put the correct time in since they've moved times. If there is a game day cancellation due to air quality contact officials/Mark. DQ reports/appeals now go to the section office for review; they are no longer reviewed at the league level.
 - 3.3 Schedule & Contest Management: Felt fall schedule with COVID; last year we chose not to penalize a school with COVID related issues, there were no forfeits; this year we agree that we will continue with not punishing teams due to circumstances out of their control. If there is a tie with league wins/losses we will have an emergency AD meeting with Felt to analyze the situation and determine the outcome.
 - 3:4 SJS Administrative Workshop Follow Up: Felt stated that leagues have D & O insurance; school districts have it; the section investigated how as a league we can get D & O insurance, at approximately \$2200/year. CIF is going to pay for it, however we have to become a 501.3c or have the league fall under either Modesto or TUSD D & O. There is a fee of \$933 to complete the application to receive a 501.3c status. Ed recommends that we take advantage of the section office, pay the application fee and become a 501.3c; this will provide coverage for the league as a one-time expense. The league decided that we will speak with the two districts first and then make a decision.

In order to host a playoff games sites now have to complete and submit documents to the section. Ed stated that we need to fill out the paperwork and get it submitted. Dave Walls stated it helps the section understand the ability of each site and then also to know what sites are available to host based on the need of the sport.

Realignment Cycle – realignment was put on hold due to COVID; this upcoming spring, 2022, we need to send any nominations for any interested principals and/or ADs to serve on the committee. 2022-2023 the process will start in January and be concluded by April. A realignment is a four-year term.
